Welcome to the TWF Wrestling Academy. This document is an overview of the class, and a review of what is expected from you. This is for you to keep and reference.

During the duration of your stay at TWF we will provide you with benefits no other wrestling organization can offer such as:

- A professional ring to work in
- Character development coaching
- Promo (speaking performance) coaching
- Nutritional, health and exercise advice
- Bi-weekly television productions to participate in
- Monthly live shows (with audiences of 150+) to participate in
- Access to a TV and DVD production studio
- And most importantly the inside info on the inner workings of the wrestling business

During your training we will cover the fundamentals of professional wrestling and when you have graduated you will have not only a diploma, but the knowledge to work a professional wrestling match from start to finish. Once you graduate you will be able to wrestle in any professional promotion across the United States. We will cover:

- In ring skills
- Promo and Theatrical performance skills
- Cardio and fitness training
- Character development

On your first day of training you are to bring a \$200 deposit. IF YOU CAN NOT COME UP WITH THE DEPOSIT, THEN THE WRESTLING BUSINESS IS NOT RIGHT FOR YOU. The total cost of training is \$2,000.00, which must be paid off in one year. You can pay all up front or make monthly payments. If our payment schedule is too difficult to adhere to, a payment plan can be negotiated but only after the deposit is made and you have shown dedication. If you do not have the time or money to pay your dues, than we do not have the time or money to waste on training you. Here is what is expected of you during your stay at the TWF Wrestling Academy:

- SHUT UP AND LISTEN: We don't care about what you know or have heard.
- BE PROMPT: Show up on time and call a trainer if there are any issues
- ASK QUESTIONS: If you do not grasp a concept, ask about it
- BE DEDICATED: Show up to all TWF events (including the not-so-fun ones IR: fund raisers, promotional days or appearances)
- ACCEPT WHAT YOU ARE GIVEN: If we say that you're not ready to wrestle, then you don't wrestle. Be happy with security detail or ref'ing for the time being.
- PAY YOUR DUES: Work hard in and out of the ring, do what is asked of you, make your payments on time, and accept the fact that as a green wrestling it will take time and dedication to earn respect.

I acknowledge that the Total Wrestling Federation (Hereinafter "TWF") has not purchased and does not provide any medical or accident insurance to cover such expenses. Any such insurance is my responsibility. I waive, release, absolve indemnity and agree to hold harmless TWF, it's members, officers, directors, employees, volunteers, agents or any other representative of TWF against any and all causes of action, claims, demands, losses expenses, or ability. In addition, I understand that my conduct, if deemed inconsistent with the rules of good sportsmanship and the TWF Rules and Regulations may result in my expulsion from this and other programs. I agree that if registered as a member of the TWF, the TWF staff may audit my status at any time if I fail to pay my dues in the form of volunteer work, training hours, performances, and monetary payments.
